Evaluation – Live Find Announcement, NY-TF1, December 1-2, 2018

New York Task Force One (NY-TF1) is hosting a National Urban Search and Rescue (US&R) Response System (the System) Canine Search Team (CST) Certification Evaluation – Live Find (CSTCE-LF) in Staten Island, New York City, NY on December 1-2, 2018.

The CSTCE-LF is open to System candidates who have passed a Foundation Skills Assessment and are seeking to certify, or re-certify, as System CSTs. Space is limited to 24 applications. The due date for the application is November 15, 2018. Application confirmation will be sent by email to the member taking the test. Applications should be typed, signed and submitted by email to Scott Mateyaschuk at: scott.mateyaschuk@nypd.org.

There will be no pre-evaluation meeting, two weeks before the test, the Chief Evaluator will send an email to all participants with their testing times, staging instructions and any additional evaluation information. Applicants do need to attend the debriefing held at the end of each day.

Transportation: Transportation to and from the airport, hotel and the evaluation site is the

responsibility of the candidate.

Airport: Newark International Airport (EWR)

Lodging: A hotel block HAS NOT been established; refer to the attached Logistics

Letter for recommended hotels.

Participants need to provide their own personal protective equipment appropriate (PPE) for a rubble pile and teams without PPE will not be allowed to participate in the evaluation. Portable kennels are the responsibility of the participants.

There will be no registration fee for this evaluation, but task forces will be responsible for their members' travel, lodging and per diem expenses. This CSTCE is within scope of Readiness Cooperative Agreement funding for allowable costs, provided the individual's task force has budgeted for this expense. Task Force Representatives are asked to coordinate this information as appropriate with their Task Force Training Managers.

All applications for evaluation must be signed by the Task Force Training Manager and Canine Coordinator who shall verify by their signature that the applicant has met all evaluation criteria, including successful completion of the FSA. Applications that are not signed will not be processed.

Candidates are expected to be familiar with the guidelines set forth in the Canine Search Team Certification Process found in the CST-LF Handbook (www.femacanine.org) and adhere to the Code of Ethics and Aggression Policy.
