Nevada Task Force 1 (NV-TF1) is hosting a National Urban Search and Rescue (US&R) Response System Task Force Leaders (TFL) Course in Las Vegas, Nevada on 21-23 May, 2018. There will be no registration fee for this course, but each Task Force will be responsible for its members' travel, lodging, rental car and per diem expenses.

Space is limited to 56 applications or 2 per Task Force. **The due date for the application is April 30, 2018.** Registration confirmation will be sent by email after completing the registration link below.

Transportation: Transportation to and from the airport, hotel and the learning site is the responsibility of each student. However, NV-TF1 will support all reasonable requests.

Airport: Las Vegas International (LAS); which is 18 miles from the hosted hotel.

Hosted Lodging: Springhill Suites, 2910 E. Craig Road, North Las Vegas, NV 89030. The cost is \$106.00 per night plus tax of 13%.

Class attendees will call and make reservations with the hotel directly by calling 1-702-522-9200 and asking to book under the "FEMA GROUP" with the above listed dates. The rate code is "GRPG". **Reservations must be booked prior to April 30, 2018**.

Class location: NV-TF1 Warehouse, 3955 N. Pecos Road, North Las Vegas, NV 89115; which is 1.7 miles from the hosted hotel.

Prerequisites: Participants must meet all the general training requirements found in the 2013 FEMA TPAM including having ICS 300 and ICS 400 completed.

Participants must complete the Task Force Leader - Computer-Based Training (CBT) (9P7130) prior to attending this class and bring their certificate to the first day of class.
